The below Military Household Goods rates are effective **May 1, 2021 through April 30, 2022**. These rates are only applicable if supported by a Government Bill of Lading (GBL). Please also note that the accessorial charges are subject to change at any time.

### **ACCESSORIAL CHARGES:**

- 1) Rates are subject to a Bunker Fuel Charge in effect at time of shipment. Any change in the Bunker Fuel Charge as published in Rule 10C shall be for the account of the cargo.
- 2) Rates are subject to an Intermodal Fuel Charge in effect at time of shipment, if applicable. Any change in the Intermodal Fuel Charge (IFC) as published in Rule 10C shall be for the account of the cargo.
- 3) Rates are subject to an Intermodal Market Adjustment in effect at time of shipment, if applicable. Any change in the Intermodal Market Adjustment (IMA) as published in Rule 10C8 shall be for the account of the cargo.
- 4) Rates are subject to an Environmental Recovery Fee in effect at time of shipment, if applicable. Any change in the Environmental Recovery Fee (ERF) as published in Rule 10C1 shall be for the account of the cargo.
- 3) Rates are assuming that SHIPPER will file Electronic Export Information (EEI/SED) directly with Census. However, if Carrier prepares there will a \$100 charge for this service. Any changes in the Electronic Export Information (EEI/SED) as published in Rule 10I shall be for the account of the cargo.
- 4) Any shipments containing hazardous cargo as defined by CFR-49, will be subject to a hazardous cargo administration fee of \$200 per container/trailer, unless otherwise exempted by a specific rate item publication. Any changes in the Hazardous Cargo Administration Fee as published in Rule 10A shall be for the account of the cargo.
- 5) Rates are subject to a Total Accessorial Charge (TAC) in effect at time of shipment. Any changes in the above charges as published in Rule 10AA shall be for the account of the cargo.
- 6) A Puerto Rico Ports Authority Enhanced Security Fee will be assessed at \$73 per container/trailer for all shipments to Puerto Rico. Any changes in the above charges in Rule 10J1 shall be for the account of the cargo.
