For the purpose of applying for and obtaining credit from TOTE Maritime, Applicant directly or through its authorized representative undertakes and agrees as follows:

Applicant understands and will comply with all applicable laws and regulations administered by the FMC, STB, or any other governmental agency, including laws and regulations imposing obligations upon shippers, receivers and carriers for payment of all charges within applicable time periods. Applicant will be absolutely, unconditionally responsible to TOTE Maritime for payment of all freight and related charges due, regardless of whether or not funds for payment have been advanced by Applicant to any freight forwarder, agent, connecting carrier, NVOCC, consolidator, shipper's agent, or intermediary of any kind.

Applicant hereby authorizes TOTE Maritime to make such investigation and inquiries as TOTE Maritime deems appropriate in evaluating this application, and hereby consents to disclosure of such information as TOTE Maritime may request in connection with such evaluation. Nothing herein contained shall limit TOTE Maritime from exercising its absolute discretion to refuse to extend credit, or, where credit has been extended, to limit or restrict any of TOTE Maritime's rights to collect payment of any or all outstanding charges on any shipment prior to loading, discharge, or delivery of such shipment, or of any other shipment.

Upon approval of credit, all charges for TOTE Maritime's freight services shall be due 30 days from date of sailing unless otherwise specified in writing by TOTE Maritime. Late payments shall be assessed interest as provided in TOTE Maritime's applicable tariff. Late payments shall bear interest at the rate of the lesser of 1% above the prime rate utilized by Key Bank, Tacoma, Main Branch, or the highest rate permitted by applicable law. This understanding shall continue in effect until terminated by written notice by either party, provided however that termination shall not extinguish any obligations existing as of the date of such termination.
